Daniel Kaniewski is Managing Director, Public Sector Innovation at Marsh & McLennan Companies. Prior to joining the firm in February 2020, Dr. Kaniewski was Deputy Administrator for Resilience at the Federal Emergency Management Agency (FEMA). In this role he was FEMA's second ranking official and led the agency's pre-disaster programs. He was unanimously confirmed by the U.S. Senate on September 14, 2017. He was also Chair of the Organization for Economic Cooperation & Development (OECD) High Level Risk Forum, comprised of risk managers from the 36 OECD member nations. Before FEMA, he led the Global Resilience practice at AIR Worldwide, a catastrophe risk modeling firm. He was also a Senior Fellow at the Center for Cyber & Homeland Security. Earlier he was Assistant Vice President and Deputy Director of the Homeland Security Policy Institute at George Washington University. Dr. Kaniewski was Special Assistant to the President for Homeland Security and Senior Director for Response Policy in the George W. Bush Administration, where he managed over 200 Presidential disaster declarations. Prior to his White House service he co-founded the Homeland Security Policy Institute. He earlier held positions at FEMA, the Congressional Fire Services Institute, and on Capitol Hill. Dan began his career in homeland security as a firefighter/paramedic. Dr. Kaniewski has served on the adjunct faculty of the Georgetown University School of Foreign Service, on the District of Columbia Homeland Security Commission, and as a term member of the Council on Foreign Relations.
